Radio application procedure:

1. Complete application form, ask your club's radio officer for a letter to confirm your membership, fax/email BOTH documents to ORRA.
2. A membership invoice will be issued via fax /e-mail by ORRA.
3. Pay the required amount, using the allocated reference number.
4. Keep a copy of the application form and proof of payment until the membership card is received in the post.

PLEASE NOTE: Application forms for two-way radio user authority is issued by the Off-Road Radio Association (ORRA) and is only issued to members of registered Clubs / Organisations.

INCOMPLETE APPLICATIONS OR APPLICATIONS WITHOUT MEMBERSHIP CONFIRMATION FROM CLUB'S RADIO OFFICER WILL BE IGNORED

I understand that this user authority issued by ORRA is valid for the ICASA financial year (currently 1 April-31 March) regardless of when in the year the application is made.
